OWNER DEFAULT

If all charges are not paid as agreed to herein this Boarding Agreement, the Operator reserves the right to offer the animal(s) for public sale or otherwise dispose said animal(s) in any manner deemed appropriate to recover all or part of boarding fees, and additional charges as set forth herein this Boarding Agreement. It is understood the Operator maintains sole and absolute discretion, whereupon all proceeds, less costs (if any) collected shall be subtracted from the outstanding charges. **However,** if the proceeds do not satisfy the unpaid charges the Pet Owner shall remain liable whereby additional charges may apply for recourse and/ or collection.

ABANDONMENT

If the Pet Owner fails to advise the Operator of their intention to amend the departure date as set forth herein this Boarding Agreement, a 2 week (14 calendar days) grace period shall apply. However, if said grace period expires the animal(s) may be deemed abandoned, whereby the aforementioned whereby the Owner Default conditions shall apply. **Please note:** the Operator will attempt to contact the Pet Owner and/ or alternate contact as described in the Pet Owners Details. Phone records, dates and times will be recorded.

OPERATORS DISCLAIMER

The Pet Owner understands the Operator, its employees or agents thereof shall be **Held Harmless** for but not limited to; Feline Influenza, injury, death, loss or damage of any kind whatsoever that may occur to any animal while in the care and/ or custody of the Operator.
